


SITE GRADING PLAN

- GENERAL CONSTRUCTION NOTES:**
1. THE LOCATION AND DEPTHS OF EXISTING UTILITIES SHOWN ARE APPROXIMATE. THE CONTRACTOR WILL BE RESPONSIBLE FOR SCANNING THE AREA OF WORK TO IDENTIFY TO HIS OWN SATISFACTION THE EXTENT OF UTILITIES PRESENT INCLUDING THE UTILITIES INDICATED TO BE PRESENT, THOSE NOT SHOWN, AND THOSE SHOWN TO BE IN A DIFFERENT LOCATION. WHERE NECESSARY TO CONFIRM AND AVOID UTILITY CONFLICTS, POT HOLE EXISTING UTILITIES TO CONFIRM LOCATIONS AND DEPTHS. DOWSING OR ANY OTHER TYPE OF DIVINATION METHOD IS NOT CONSIDERED AN ACCEPTABLE PRACTICE FOR LOCATING UTILITIES.
 2. PHYSICAL SITE FEATURES OUTSIDE THE AREA OF WORK OR THOSE FEATURES NOT RELEVANT TO THE WORK BEING PERFORMED ARE NOT SHOWN FOR CLARITY.
 3. ALL EXISTING VEGETATED AREAS DISTURBED DURING CONSTRUCTION MUST BE REVEGETATED IN ACCORDANCE WITH THE PROJECT VEGETATION PLAN, SEE DETAIL B, SHEET CG501.
 4. PROVIDE ALL TRENCH SECTION IN ACCORDANCE WITH DETAIL D, SHEET CU501.
